

If your District Court hasn't begun scanning documents yet, it soon will.

This means changes in the appearance of documents filed in Court.

We have updated our forms to accommodate a wide variety of district court rules:

- ◆ Larger margins, so that if scanned documents are printed later, all the text will be printed, no matter what kind of printer is used
- ◆ The space on the upper right corner is larger, so that the file stamp will not overlay any of the text
- ◆ Some processes, such as returns, have been moved to a separate sheet, so that forms will not need to be double stamped.

- ❖ *Ch. 60 & 61 Debt Collection*
- ❖ *Personal Property Tax Collection*

To the best of our knowledge, there were no changes to forms because of legislation passed in the 2008 session

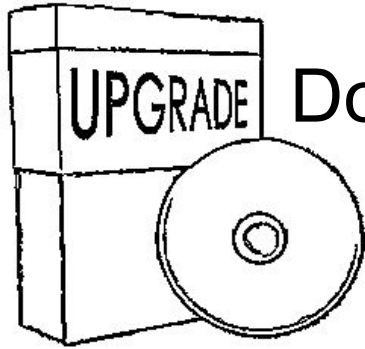
